If there is an ok location, here is the general permitting process.

Dane County Highway no longer accepts permit applications by paper or email. All Permit Applications are now all electronic. Please navigate to the current Dane County Highway Department "Highway Permit Applications" page or use this link <https://highway.countyofdane.com/permits>.

You can also go directly to the online application web site RTVision <https://wi-co-dane.onegov.rtvision.com/>.

Dane County Highway also no longer accepts checks or bills/invoices companies as in the past. Once I receive the online application, I do a preliminary review and/or make a site visit depending on the permit type. I then create the online invoice. You will then receive an automated invoice notification. Payment is through the online application by credit_card only. Payment must be made before the permit is issued.
